Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** the nominee listed and **FOR** Proposals 2-5:

1. Election of Directors:  
01 - Stephanie Bowers
2. Ratify the appointment of Marcum LLP as the Company's independent registered public accounting firm for the fiscal year ending December 31, 2022.
3. Approve, in an advisory vote, the compensation paid to the Company's named executive officers, as presented in the proxy statement.
4. Approve an amendment of the Company's 2018 Omnibus Incentive Compensation Plan to increase the number of shares issuable under the plan by 8,000,000 shares.
5. Approve an amendment and restatement of the Company's Employee Stock Purchase Plan to, among other things, increase the number of shares issuable under the plan by 1,250,000 shares.
