SCG will now offer the Novatel Wireless MiFi[®] brand IoT portfolio of specialized and scalable telematics and telemetry solutions, including the MiFi Powered SA 2100 M2M LTE gateway series, throughout the UAE, Qatar and Bahrain. Under the new alliance, SCG partners will now have access to a wide range of customizable IoT product lines for utilities, RMAC, ATMs/Kiosks, digital signage, fleet, automotive, usage based insurance, mobile workforce and other M2M applications that are growing in demand.
